Red Flags in Solar Service Contracts

With the recent surge in "free installation" offers (looking at you, SolarCity 2025 promo), consumers need to recognize contractual landmines. Three clauses that should trigger immediate consultation:

Automatic renewal terms beyond 3 years Vague "environmental surcharge" provisions Third-party liability limitations

A current case in Texas courts involves a homeowner sued for \$12,000 after attempting to remove panels from their inherited property. The lesson? Never sign a service agreement without understanding transferability terms.

As we approach the 2025 summer peak season, remember: quality solar service isn't about finding the cheapest option. It's about protecting your energy investment through informed maintenance choices. Those who skip professional servicing to save \$200/year often end up paying \$2,000+ in premature replacements.
