No local service centers

Top-performing Chinese manufacturers like JinkoSolar and Trina Solar dominate commercial projects through Bogotá-based distributors. Their 25-year performance warranties--though sort of optimistic--give buyers peace of mind.

## Practical Installation Considerations

Roof orientation matters more than you'd think. Medellín installations require 15°-20° tilt for optimal output. Coastal projects in Cartagena? They need anti-corrosion frames to handle salt spray.

Pro tip: Always request shadow analysis reports. A single palm tree can reduce system efficiency by up to 22% during peak hours.

## Latest Government Incentives

Colombia's Law 2099 now offers:

- 50% income tax deduction for commercial solar investments
- VAT exemption on imported solar equipment
- Net metering through local utility companies

The catch? You'll need an ANDI-certified installer to qualify. Applications take 8-12 weeks through the Energy Planning Unit's new online portal.
